Terms and Conditions of the Manulife InvestChoice Promotion for Existing Customers

1. The Manulife InvestChoice Promotion for Existing Customers (“the Promotion”) is taking place from 16 April 2021 to 30 June 2021, both dates inclusive (“Promotion Period”).
2. Only existing holders of Manulife InvestChoice accounts are eligible to participate in the Promotion (“Eligible Clients”).
3. Each Eligible Manulife InvestChoice Account, in a single name or joint-name, opened by Eligible Client(s), is entitled to one set of reward specified in points 4 below.

4. Front-end fee refund as a reward: The front-end fee of (i) the first three monthly subscriptions under the Monthly Investment Plan, and (ii) any subscriptions before the End Date of the Holding Period, will be refunded up to the amount of HK\$500, subject to the condition mentioned below.

The condition is that, the Eligible Client must (i) set up a Monthly Investment Plan for the first time under the Manulife InvestChoice Account during the Promotion Period and complete the first three monthly fund subscriptions successfully. The minimum monthly subscription amount starts at HK\$1,000 per class in a fund, and a minimum holding of HKD\$20,000 per class in a fund is required to initiate the Monthly Investment Plan in the fund.

Definition of “Holding Period” is as follows:

Each Client who meet the condition stated in point 4 will receive an email from Manulife Investment Management (Hong Kong) Limited (“Manulife”) within four months following the end of the Promotion Period. The reward will be deposited into the HKD Cash Account of the Eligible Client’s Manulife InvestChoice Account within five months after the end of the Promotion Period.
6. The Promotion excludes any staff or agent of Manulife group.
7. Each Eligible Account can only receive one set of reward. For a joint-name account, only one set of reward will be deposited into the HKD Cash Account held by the same joint-holders.
8. Manulife reserves the right to amend these terms and conditions at any time without prior notice.
