Terms and Conditions of the Manulife InvestChoice Promotion for selected existing Manulife customers

1. The Manulife InvestChoice Promotion for selected existing Manulife customers (“the Promotion”) is taking place from 1 November 2021 to 31 December 2021, both dates inclusive (“Promotion Period”).
2. Only selected existing holders of Manulife Advanced Fund SPC (“MAF”), Manulife Global Fund (“MGF”) and/or Manulife Hong Kong Series (“MHK”) accounts who have directly received an invitation issued by Manulife Investment Management (Hong Kong) Limited (“Manulife”) are eligible to participate in the Promotion (“Eligible Clients”).
3. Eligible Client who opens a new Manulife InvestChoice Account in a single name (“New Account”) in the Promotion Period and fulfills the requirements set out below, is entitled to the HK\$300 cash reward.

Requirements: an Eligible Client must complete the whole upgrade process online within the Promotion Period, which includes: (i) successfully open a new Manulife InvestChoice Account; (ii) transfer ALL the fund units of MAF, MGF and/or MHK held by the Client to the New Account; (iii) close the MAF, MGF and/or MHK account; (iv) enable the New Account to meet the condition that, during the “Holding Period” as defined below, the average daily combined balance of the cash holdings and/or the value of fund units in the New Account must not fall below the total value of all the fund units transferred in.
